MEMBERSHIP REQUIREMENTS

- I. New member applicants are required to attend a Club meeting, held the first Wednesday of each month at 7:30 p.m., for the purpose of introduction to the general membership.
- II. New applicants must have a reference or sponsor.
- III. Applicants must be citizens of the United States, 18 years of age or older, a current member of the National Rifle Association (NRA), and must ascribe to the following pledge: "I certify that I am a citizen of the United States; that I am not a member of any organization which has any part of it's program the attempt to overthrow the government of the United States by force or violence; that I have never been convicted of a crime of violence and that if admitted to membership, I will fulfill the obligation of good sportsmanship and good citizenship."
- IV. Annual membership dues of \$100.00 plus a one-time initiation fee of \$25.00 are due upon acceptance to the Club. First years dues are pro-rated on a semi-annual basis.
- V. New members will be subject to a 6 month probationary period. During the probation the new member may be expelled for engaging in unsafe or destructive acts on Club property without the rights granted under Article VIII of the Club Bylaws.
- VI. New members must be eligible to possess firearms in accordance with Federal and Florida State law.
